FOR BSC IN NUTRITION AND DIETETICS**

KNDI writes to inform you on the call for the October 2024 Pre-Licensing Oral Examinations for Degree Graduates in Nutrition and Dietetics.

The Accreditation Committee has organized for oral examinations as a Mandatory Pre-Requirement for all degree graduates in nutrition and dietetics to allow the students to proceed to written examinations, registration and licensure.

Take note that the oral examinations scheduled for October 2024 will be the final Mandatory Examination for all nutrition and dietetics degree graduates who completed their studies by August 2024.

The October 2024 timetable for pre-licensing oral examination is as follows;

Item	Dates
Oral examinations application (Degree graduates only)	June 2024 – 15 th October 2024
Oral examinations application deadline (Degree graduates only)	15 th October 2024
Oral examinations administration (Degree graduates only)	21-31 st October 2024

Kindly note that failure to apply within this period shall attract a penalty of Kshs. 5,000/=
